JOINTLY DEVELOPED

Nebinger Elementary School, and the parents of the students participating in activities, services, and programs funded by Title I, Part A of the Elementary and Secondary Education Act (ESEA) agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility from improved student academic achievement and the means by which the school and parents will build and develop a partnership that will help children achieve the State's high standards.

THE SCHOOL DISTRICT OF PHILADELPHIA ANCHOR GOALS:

NEBINGER ELEMENTARY SCHOOL GOALS:

- **70% of Kinder will read on level by June 1**
- **50% of First Graders read on level by June 1**
- **55% of Second & Third Graders will read on level by June 1**
- **80% of 4th-8th Graders will score Basic, Proficient, or Advanced in Math**
- **80% of 4th-8th Graders will score Basic, Proficient, or Advanced in ELA**

SCHOOL/TEACHER RESPONSIBILITIES:

Nebinger Elementary School will:

- 1. Hold parent teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held:

- 2. Provide parents with frequent reports on their children's progress.** Specifically the school will provide reports as follows:
 - During report card conference and through interim reports 3 times a year, after Benchmark and PSSA exams, referral to RTII, and other times as needed through letter, email, parent conferences, telephone calls bi-weekly to parents*
- 3. Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:
 - By contacting the main office secretary and/or teacher to schedule an appointment during preparation periods, report card conferences, parent-teacher conferences*
- 4. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities,** as follows:
 - Parents may volunteer for student arrival, dismissal and after school programs, assist in the lunchrooms, classrooms and main office*
 - Parent may volunteer to become a member of the Home and School Association, School Advisory Council, Safe Corridors Program, tutoring, etc.*
 - Parents may observe classrooms upon scheduling an appointment to observe their child's class through the main office Secretary/Principal and during Two Chairs at a Desk held 2nd and 4th Wednesday of the month*
 - Parents are encouraged to participate in Coffee with the Principal once a month, Parent/Family Workshops, Open Houses, School Trips, Back to School Night, School Events*

PARENT RESPONSIBILITIES:

We, as parents, will:

1. *Monitor attendance.*
2. *Make sure that homework is completed.*
3. *Monitor the amount of television my child watches.*
4. *Volunteer in my child's classroom and or school events and as needed*
5. *Participate, as appropriate, in decisions relating to my child's education.*
6. *Promote positive use of my child's extracurricular time.*
7. *Stay informed about my child's education and communicates with the school by promptly reading all notices from the school or the school district either received by my child or by mail and responding, as appropriate.*
8. *Serve, to the extent possible, on policy advisory groups, such as HSA, or the school's School Advisory Council (SAC.)*

STUDENT RESPONSIBILITIES:

Students will:

1. *Do homework every day and ask for help when needed.*
2. *Come to school 95% of the time*
3. *Wear full uniforms*
4. *Read at least 20-30 minutes every day outside of school time.*
5. *Give to parents or the adult who is responsible for their welfare all notices and information received by Nebinger School every day.*

COMMUNICATION ABOUT STUDENT LEARNING:

Nebinger Elementary School is committed to frequent two-way communication with families about children's learning. Some of the ways you can expect us to reach you are:

- 1.) *Communication folders are sent home daily and communications via DOJO*
- 2.) *HSA website and weekly newsletters*
